## SUBSTITUTE ORDINANCE

WHEREAS, the Annual Appropriation Ordinance for the year 2023 (the "2023 Appropriation Ordinance") of the City of Chicago (the "City") contains estimates of revenues receivable as grants from agencies of the state and federal governments and public and private agencies; and

WHEREAS, the City through its Department of Public Health ("CDPH") has been awarded additional federal grant funds in the amount of \$230,000 by the United States Department of Health and Human Services ("HHS") Adult Viral Hepatitis program; and

WHEREAS, the City through CDPH has been awarded additional federal grant funds in the amount of \$3,234,000 by HHS for the Vaccine Preventable Diseases (Immunizations and Vaccines for Children) program; and

WHEREAS, the City through CDPH has been awarded federal grant funds in the amount of \$375,000 by HHS for the Outcomes to Reduce Burden of Menthol and other Flavored Commercial Tobacco Products program; and

WHEREAS, the City through CDPH has been awarded federal grant funds in the amount of \$3,418,000 by HHS for the Injury Prevention and Control Research program; and

WHEREAS, the City through its Department of Family and Support Services has been awarded state grant funds in the amount of \$30,253,000 by the Metropolitan Mayors Caucus, which grant funds are sourced from the Illinois Department of Human Services, for the Supporting Municipalities for Asylum Seekers program; and

WHEREAS, the City through its Office of Emergency Management and Communications ("OEMC") has been awarded additional carryover federal pass-through grant funds in the amount of \$653,000 by the Illinois Emergency Management Agency, of which OEMC will receive \$547,000 and the Department of Fire ("CFD") will receive \$106,000, for the Urban Areas Security Initiative program; and

WHEREAS, the City through CFD has been awarded additional state grant funds in the amount of \$481,000 by Office of the Illinois State Fire Marshal for the Fire Academy Training and Improvement program; and

WHEREAS, Exhibit A of that certain ordinance with respect to Fund 925 and adopted by the City Council of the City on October 4, 2023 misstated the total of the awards from agencies of the State of Illinois (the "Awards from the State") as \$866,221,000; however, the correct total of the Awards from the State should have been \$866,216,000, and therefore the related add amount column in Exhibit A will reflect a reduction of \$5,000 in the total Awards from the State; now, therefore,

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The amount of \$38,644,000 is hereby appropriated from Fund 925 - Grant Funds for the year 2023. The 2023 Annual Appropriation Ordinance is hereby amended by striking the words and figures and adding the words and figures indicated in the attached Exhibit A which

is hereby made a part hereof.

SECTION 2. To the extent that any ordinance, resolution, rule, order or provision of the Municipal Code of Chicago, or part thereof, is in conflict with the provisions of this ordinance, the provisions of this ordinance shall control. If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this ordinance.

SECTION 3. This ordinance shall be in full force and effect upon its passage and approval.
