


**CITY COUNCIL:** July 19, 2023

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Section 2-8-040 of the Municipal Code of Chicago, which allows erection of honorary street designations, the Commissioner of the Chicago Department of Transportation shall take the necessary action for the Standardization of W. Grace Street between N. Meade and N. Melvina as “Honorary PFC Chrys Carvajal Way”.

SECTION 2. This ordinance shall take effect upon its passage and publication.

WHEREAS, Chrys was an innocent victim of street violence and leaves a hole in the hearts of so  
many who loved and respected him and who are deeply grieving his loss; and

WHEREAS, Private First Class Carvajal proudly served our Country as a member of the  
National Guard, completing his basic training at Fort Jackson, South Carolina and waiting to be  
stationed at a military base in Riverside; and

WHEREAS, Chrys aspired to be a Chicago Police Officer, hoping to help and dedicate his life to  
the people of this great City; and

WHEREAS, Chrys was raised in Chicago, the son of Lourdes Lara (Noel) and Eliseo Carvajal  
and loving brother of Jennifer and Brittany who deeply mourn his passing; and

WHEREAS, Chrys was a positive person, always striving to better himself and work hard to  
achieve his dreams; and

WHEREAS, Chrys was a gifted athlete who had a passion for soccer, exceling in the sport at  
Chicago Academy, a much valued member of the team; and


WHEREAS, Private First Class Chrys Carvajal lost his life at the young age of 19 years,  
depriving this world of all he had yet to accomplish; and

WHEREAS, We recognize that the loss of Private First Class Chrys Carvajal underscores our  
need to work to resolve the senseless violence on our streets and the loss of the talents and  
treasure of our youth who were lost too soon; and

WHEREAS, It is our fervent hope that those who perpetrated this horrendous and senseless  
crime be brought to justice; and

NOW, THEREFORE, BE IT RESOLVED, That we, the Mayor and members of the City  
Council of the City of Chicago, gathered here in assembly this 19th day of July 2023, A.D., do  
hereby honor the memory of Private First Class Chrys Carvajal and grieve the loss of such an  
exceptional person.

BE IT FURTHER RESOLVED, That a suitable copy of this resolution be prepared for
