ODINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 13-H in an area bound by:

The alley next north of and parallel to West Ainslie Street; North Oakley Avenue; West Ainslie Street; a line 62.00 feet west of and parallel to North Oakley Avenue; a line 67.50 north of and parallel to West Ainslie Street; a line 54.00 feet west of and parallel to North Oakley Avenue; a line 76.50 feet north of and parallel to West Ainslie Street; and a line 46.50 feet west of and parallel to North Oakley Avenue.

To those of a RM-4.5 Residential Multi-Unit District.

SECTION 2. This ordinance takes effect after its passage and due publication.


