Windows will be double hung high efficiency as detailed in the architectural plan.

Iron fencing will be installed in the front and a combination of iron and wood fencing will be installed down the side of the house.

All sidewalks and patio areas will be concrete.

The yard and the front façade will be landscaped with a mixture of sod, plants, trees and decorative rocks.
