ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

9-64-050 Parking restrictions – Parking for persons with disabilities.

SECTION 1. Chapter 9-64-050 of the Municipal Code of the City of Chicago is hereby amended by inserting the language underscored, and deleting the language struck through, as follows:

(e) (1) Upon completion of the parking survey and the recommendation that a restricted parking space be installed, the Comptroller comptroller shall inform the applicant of the proposed location of the proposed parking space and shall report such recommendation to the alderman of the ward in which the restricted parking space will be located and to the City Council Committee on Pedestrian and Traffic Safety, or its successor committee. city council committee on pedestrian and traffic safety. Upon determining that an application for a restricted parking space should not be recommended, the Comptroller eomptroller shall provide written notice to the person submitting the application as well as the alderman of the ward in which the application was made. Any person whose application has not been recommended because the city has determined that a restricted parking space cannot be situated in a location accessible to the applicant's primary residence or was not recommended on the basis of the extent of the alternative accessible off-street parking at their his or her primary residence may, within ten days of the date of denial, respond in writing to the Mayor's Office for People with Disabilities mayor's office for people with disabilities requesting a review of the findings and stating reasons in support of reconsideration. The mayor's office for people with disabilities shall conduct such review and shall make a determination within 30 days of the date the request for reconsideration was made. The Mayor's Office for People with Disabilities mayor's office for people with disabilities shall report its determination to the comptroller, who shall follow, and, if appropriate, reevaluate the application in light of, such determination.

(4) In the event that (1) the <u>Department of Finance_department of finance_does not recommend the creation of a restricted parking space, (2) a request for review with the <u>Mayor's Office for People with Disabilities mayor's office for People with disabilities is not timely made, (3) a request for review with the <u>Mayor's Office for People with Disabilities mayor's office for People with Disabilities mayor's office for People with Disabilities is timely made but a determination is issued consistent with the earlier findings of the comptroller, and/or (4) the <u>City Council eity council-fails</u> to approve creation of a restricted parking space, the <u>Department of Finance_department of finance_shall refund the applicant their his or her_application fee directly. In the event that the Department does not recommend creation of a restricted parking space based on a restricted parking space not being situated in a location accessible to the applicant's primary residence or on the basis of the extent of the alternative accessible off-street parking at their primary residence, the applicant shall be notified when a restricted parking space accessible to the applicant becomes available, and they may reapply for such space, and shall be given priority, based on the date of their original denied application, if such new application is made within 30 days of the mailing of the notice.</u></u></u></u>

SECTION 2. This ordinance shall take effect 30 days after passage and publication.
