#### **ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RM-4.5 Residential Multi-Unit District symbols and indications as shown on Map Number 9-G in the area bounded by:

A line 50.0 feet north of West Eddy Street; the public alley next east of and parallel to North Racine Avenue; a line 25.0 feet north of West Eddy Street; and North Racine Avenue

to those of an RT-4 Residential Two-Flat, Townhouse and Multi-Unit District, and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.



#### Dear Property Owner:

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about May 24, 2023, the undersigned will file an application for a change in zoning from RM-4.5 Residential Multi-Unit District to RT-4 Residential Two-Flat, Townhouse and Multi-Unit District on behalf of the applicant, Gregory Davey and Sara Whaley Davey, for the property located at 3537 N. Racine Avenue. The applicant is also the owner of one of the three condominium units at the subject property. The other owners of condominium units at the subject property are (a) Joshua Sprague, and (b) Michael Biegel and Robert David Louis Fleming, IV.

The purpose of the proposed change in zoning is to return the zoning district to the zoning district previously in effect for the subject property; the subject property had been rezoned to RM-4.5 on January 26, 2022, to cause the building, which was constructed by its developer to be slightly larger than the approved plans filed for its building permit and nonconforming as to floor area (3,780.4 sq.ft., 30.4 sq. ft. in excess of the maximum in the RT-4 zoning district), to conform to the bulk requirements of the Zoning Ordinance. After returning the zoning district to RT-4, the subject property will be a legal nonconforming ("grandfathered") development. No new construction is planned at this time.
