

NORTHWEST ELEVATION (FACING PARKING LOT)

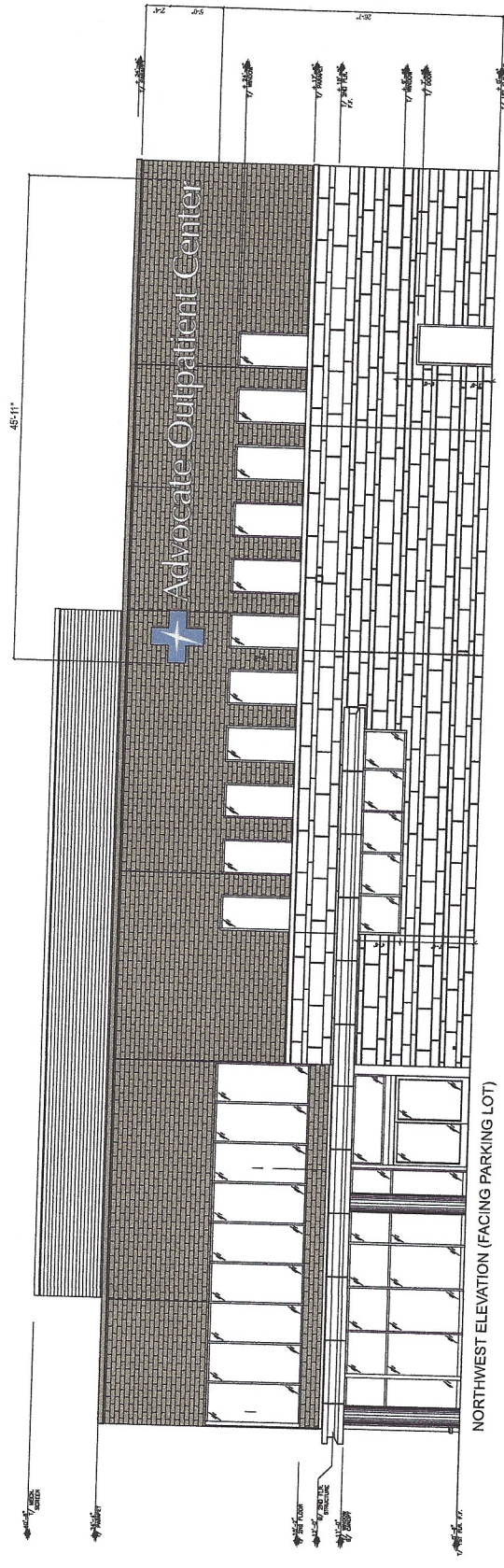

NORTHWEST ELEVATION (FACING PARKING LOT)

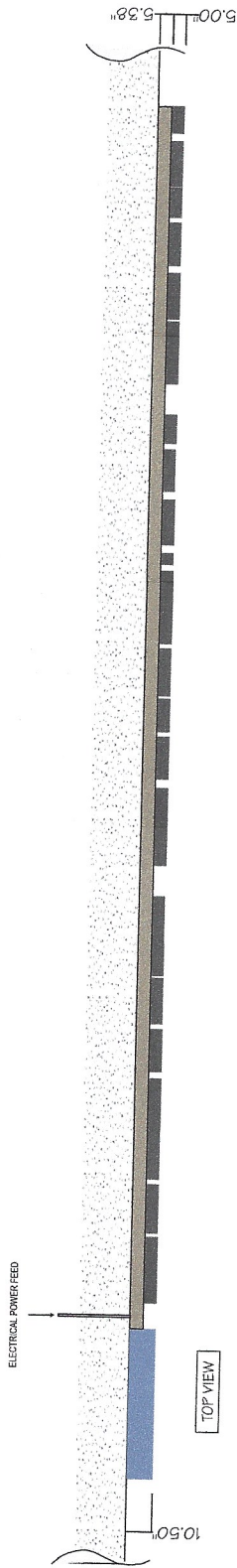

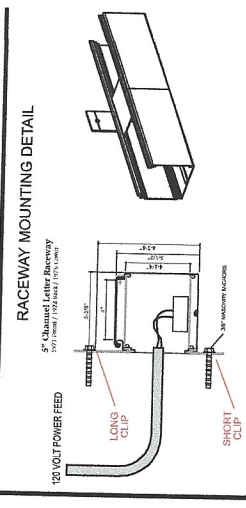
