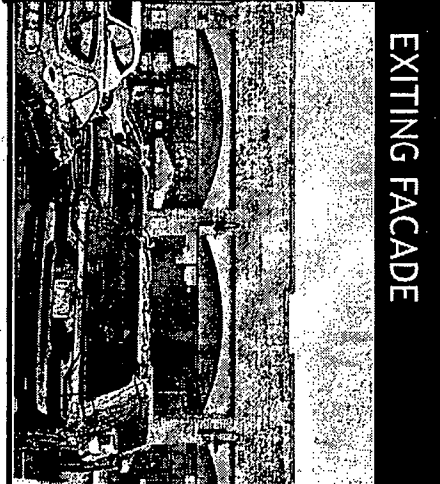
Sign Location



SIGN 1 : SITE VIEW



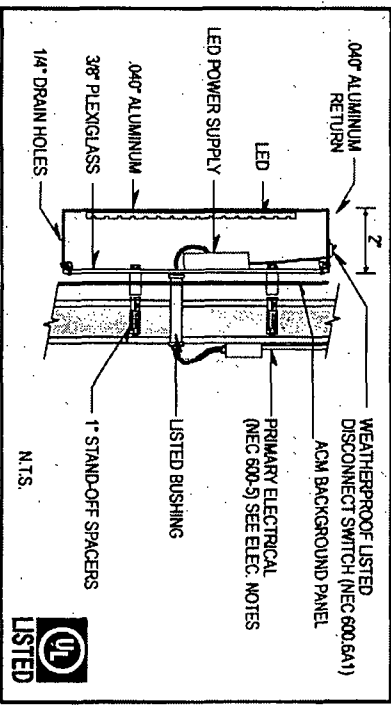
