#### ODINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the C1-2 Neighborhood Commercial District symbols and indications as shown on Map No. 9-H in an area bound by:

A line 246.00 feet south of and parallel to West Waveland Avenue; North Ashland Avenue; a line 271.00 feet south of and parallel to West Waveland Avenue; and the alley next west of and parallel to North Ashland Avenue.

To those of a B2-3 Neighborhood Mixed-Use District.

SECTION 2. This ordinance takes effect after its passage and due publication.




