BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-2 Community Shopping District symbols and indications as shown on Map No. 11-H in an area bound by:

The alley next north of and parallel to West Irving Park Road; a line 81.20 feet east of and parallel to North Wolcott Avenue; West Irving Park Road; and a line 56.20 feet east of and parallel to North Wolcott Avenue.

To those of a B2-3 Neighborhood Mixed-Use District.

SECTION 2. This ordinance takes effect after its passage and due publication.

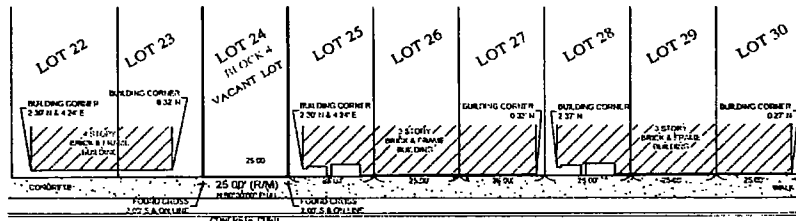


IRVING PARK ROAD

IRVING PARK ROAD

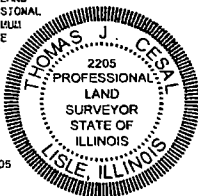
