ORDINANCE

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1.** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the C1-2 Neighborhood Commercial District symbols and indications as shown on Map No 8-I in an area bounded by:

**South Archer Avenue; a line 124 feet southeast of and parallel to South Campbell Avenue as measured along the South right-of-way line of South Archer Avenue and perpendicular thereto; the alley next south of and parallel to South Archer Avenue; and a line 76 feet southeast of and parallel to South Campbell Avenue as Measured along the south right of way line of South Archer Avenue and perpendicular thereto,**

to those of a C2-2 Motor Vehicle-Related Commercial District

**SECTION 2.** This Ordinance shall be in force and effect from and after its passage and due publication.
